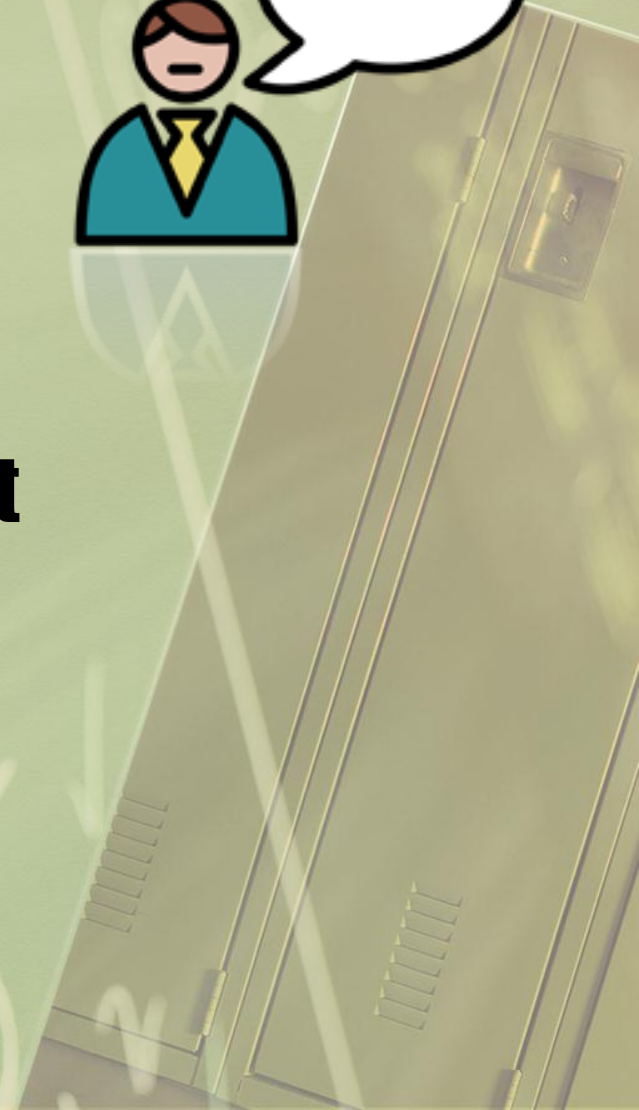
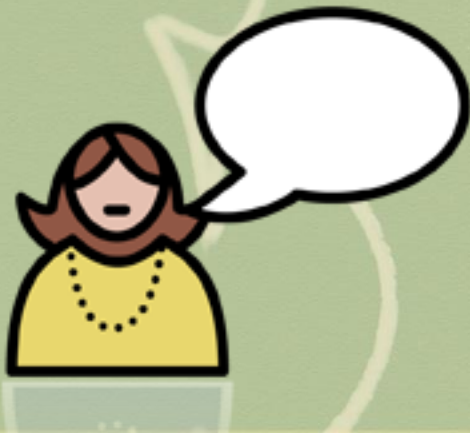

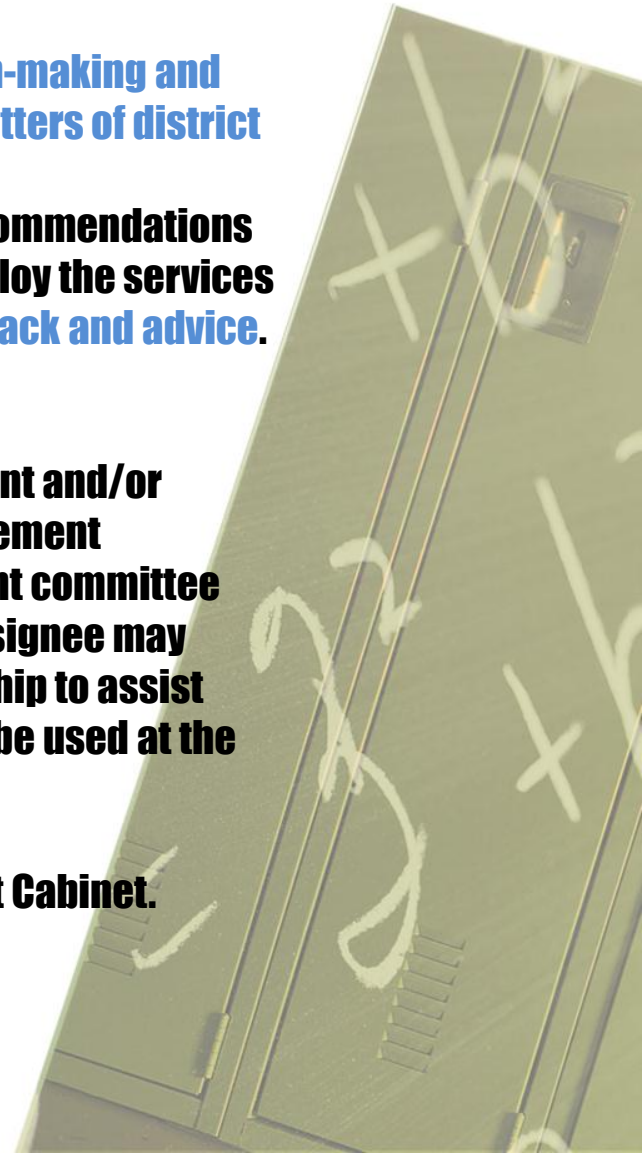
# Administrative Regulation

## Role of Committee:

- **The District Educational Improvement Committee is a decision-making and advisory group for the Superintendent and School Board in matters of district planning, operations, policies and procedures.**
- **The Superintendent is not bound to accept or act upon the recommendations from the committee. However, the Superintendent should employ the services of the committee for the purpose of gaining stakeholder feedback and advice.**

## Agenda and Minutes:

- **Agenda preparation shall include input from the Superintendent and/or central administrative staff, from campus educational improvement committees (CEIC), from district wide educational improvement committee members (DEIC) and other sources. The Superintendent or designee may appoint a steering committee created from the DEIC membership to assist with agenda topics; the steering committee's assistance may be used at the chairman's discretion.**
- **Minutes must be posted on the KISD website.**
- **Agenda items and minutes will be reviewed by Superintendent Cabinet.**



# Board Policy

In compliance with Education Code 11.251, the District educational improvement committee shall advise the Board or its designee in establishing and reviewing the District's educational goals, objectives, and major Districtwide classroom instructional programs identified by the Board or its designee. The committee shall serve exclusively in an advisory role except that the committee shall approve staff development of a Districtwide nature. The Board or its designee shall meet periodically with the committee to review the committee's deliberations.

# Board Policy

The chairperson of the committee shall set its agenda, and shall schedule at least **four meetings per year**. Committee meetings shall be held **outside of the regular school day** and shall be **advertised to the public**.

The Superintendent or designee shall ensure that the District-level committee obtains broad-based community, parent, and staff input. The committee, in conjunction with District employees not serving on the committee, shall be responsible for providing information in a systematic manner to the District communications department, which shall use appropriate resources to provide information to the community. Communications may include, but not be limited to, the following:

1. Periodic public meetings, as needed, to gather input and provide information to the community on the work of the committee. These meetings shall be **advertised in District publications** and through the media.
2. Articles in District publications regarding **work of the committee**.

**Meeting dates, times, locations and minutes will be on the district website. Updates will be given to the Board in September and May.**
