FISCAL NOTE: Revenue from Local Sources

Background Information:

- In accordance with the Tax Levy Ordinance passed by KISD Board of Trustees on August 27, 2009, for the 2009-2010 fiscal year and/or tax year 2009.

Administrative Considerations:

- As of August 31, 2010, the current year (2009) adjusted tax levy is \$162,025,597.
- Through August 31, 2010, 98.92% or \$160,286,383 of the 2009 levy has been collected (October 2009 – August 2010).
- The balance to be collected of the 2009 levy is \$1,739,214.
- Delinquent taxes from prior year levies total \$1,481,955.
