**FISCAL NOTE: Revenue from Local Sources**

**Background Information:**

- In accordance with the Tax Levy Ordinance passed by KISD Board of Trustees on August 26, 2010, for the 2010-2011 fiscal year and/or tax year 2010.

**Administrative Considerations:**

- As of August 31, 2011, the current year (2010) adjusted tax levy is \$165,224,552.
- Through August 31, 2011, 99.20% or \$163,908,760 of the 2010 adjusted levy has been collected (October 2010 – August 2011).
- The balance to be collected of the 2010 adjusted levy is \$1,315,792.
- Delinquent taxes from prior year levies total \$1,973,969.
