



Keller High School Parking Policy 2023-2024

Vehicles parked in Keller High School designated student parking lots are under the jurisdiction of Keller High School. Students must purchase a KHS parking permit, to be hung on the rearview mirror, visible to security, prior to parking in Keller High School designated student parking lots. Parking permit fees are listed below:

General Parking Permit for 2 semesters (full year) \$50.00

General Parking Permit for 2nd semester only (half year) \$25.00

Reserved Parking Permit (Seniors Only) (full year) \$125.00

Replacement of lost or damaged parking permits will incur the same fees as listed above

Parking permits will **NOT** be sold or issued with incomplete paperwork. The parking information sheet must have all information completed and it must have both parent/guardian and student signatures (even if the student is 18). We must have accurate information for each parking permit sold. Sharing of parking permits is not permitted and may result in the loss of parking privileges. The submission of fraudulent or incorrect vehicle identification information or the use of fraudulent parking permits may result in the loss of parking privileges.

According to local policy (FNF Local), Administrators may conduct searches of vehicles on school property at any time there is reasonable cause to do so. If a student refuses to give consent, the parents of the student will be called to gain consent.

Refusal of consent will result in a loss of parking privileges and possible involvement of law enforcement.

All students, regardless of age, will be held responsible for any prohibited objects or substances, such as e-cigarettes or vaping devices, tobacco products of any kind, alcohol, drugs, weapons, etc. that are found in his/her vehicle and will be subject to disciplinary action by Keller ISD, as well as possible involvement of law enforcement.

Students have full responsibility for the security of their vehicle and must make certain it is locked and their valuables are secured. Keller High School is **NOT** responsible for loss or damages which occur while vehicles are parked on school property.

Students will not display any item on his/her vehicle or parking space which may be interpreted as offensive. The offensive nature of an object will be determined at the discretion of the KHS administration.

Any type of reckless driving (excessive speed, driving over curbs, etc.) on school property at any time will result in suspension or revocation of driving privileges. KHS will **NOT** refund parking pass fees to students who have had parking privileges suspended or revoked.

Any student parked in a handicapped parking space (without a handicapped permit), faculty lot, visitor's lot, striped area, fire lane, or other unauthorized areas will be subject to having his/her vehicle ticketed, immobilized (booted) or towed at owner's expense, loss of parking privileges, and/or disciplinary actions. **This includes parking in the numbered/reserved spaces which have been reserved by seniors.** The progression of disciplinary action is as follows:

1st Offense: Violation sticker with explanation of violation and parent notification.

2nd Offense: Vehicle immobilized (booted), AP involvement, parent notification, a \$25.00 boot removal fee and **Saturday School.**

Subsequent Offenses will result in students being assigned to In-School Suspension.

***Any parking violation may result in students being ineligible for the Senior Reserved Parking Lottery the following year.**

If a student's vehicle is immobilized because the student has not purchased a parking permit, the boot will not be removed until a permit is purchased (if the student is eligible) and the removal fee is paid. **Boots will be removed after the fee(s) are paid and a member of Security and an AP are available.** Vehicles that create safety or access problems may be towed, without warning, at the owner's expense.
