☐ Health Curriculum for Keller ISD Students

- o The Board of Trustees approved a resolution to convene the SHAC to make recommendations for the health curriculum including human sexuality instruction at their KISD board meeting on December 13, 2021.
- o Per SB 9, there was a requirement to host two public viewings of the available curriculum options. Viewings were advertised in the weekly KISD community newsletter as well as on social media.
- o January 19, 2022 First public viewing of curriculum was held in the KISD Boardroom from 4:00pm – 6:00pm. Vendors and staff that were present:

- o Brief Outline of Health curriculum presented by Kelly Vandewalker and Shannon Jenkins
 - Health is currently considered an elective and is not required for graduation
 - The proposed curriculum is based on TEKS (Texas Essential Knowledge and Skills)
 - Quavers Ed develops their own programs and teachers can choose from all kinds of materials. Parents have access to materials as well
 - Good Heart Wilcox is a textbook for teachers to use along with online support and is up to date with currently relatable information.
 - Big Decisions regards social and emotional learning. It provides a common ground and space for students to feel comfortable asking questions and having educated discussions about real world problems including sexual education
 - Each unit is an average of about 10 days
 - Alliance for Children and The Women's Center both provide support for the curriculum and are currently being used.
 The vendors are onsite at campuses to deliver age-appropriate instruction with KISD staff present to identify any students that may be affected by a lesson.
 Alliance for Children has adjusted their curriculum to meet the requirements of SB9 by including human trafficking and child abuse topics

□ Vote on Recommended Health Curriculum

- o Only district appointed SHAC members are eligible to vote
- o 19 total members present and 13 are not district employees identifying that there is a quorum of at least 51% to proceed with the vote on the curriculum
- o Concerns about having enough information and feedback from the public to vote on any recommendations for the next board of trustees meeting at this time due to low attendance at both public viewings
- o Motion for recommendations of health curriculum tabled with 6 votes in favor, 8 votes against, and 5 abstentions
- o Special meeting will need to be held before the end of March to get a SHAC voted recommendation to the board of trustees before their next meeting. Date and time will be determined and all SHAC members will be notified

- □ 2022/2023 SHAC Membership Recruitment
 - o The new membership will be aligned with the school year
 - o Will continue using a link through the district newsletter for interested parties and then vet all potential members through their school principles for recommendation for membership
 - o Membership selections will be representative of every campus and or grade level where possible
 - o Registration cut-off will be March 25, 2022
 - o Board approvals may be received by May or June and members will be contacted
- ☐ District Wellness Update
 - o Campus nurses continuously still working with students that had difficulty with vision, hearing, and spinal screenings
 - o Sherri Rich KISD Director of Employee Benefits
 - Casey Kids Fun Run still scheduled for March 26, 2022
 - All proceeds from the fun run go back to Keller ISD
 - Possibility of a SHAC table at the event to help get the word out about the committee
 - In need of a dentist for oral hygiene and a vision doctor
 - 20 vendors so far have signed up to be a part of the event
